## REACH

The term “REACH” [Registration Evaluation and Authorization of Chemicals] is a registration and reporting procedure for all chemical substances imported, manufactured or used in the EU above 1 metric ton per year, as well as highly regulated chemicals, referred to as “SVHC” Substances of Very High Concern. On June 27, 2024 ECHA’s member state committee added 1 new substance. The Candidate list of SVHC now contains 241 entries.

**Declaration:** This will certify that to the best of our knowledge, the chemicals on the Candidate List of Substances of Very High Concern referenced above are not intentionally added or present in any CTM product.

## TSCA PBT
